THE CLINIC PROVIDES TECHNICAL ASSISTANCE AND TRAINING TO BUILD FINANCIAL SECURITY STRATEGIES INTO THE DAILY INTERACTIONS OF FRONT-LINE STAFF OF SOCIAL SERVICE ORGANIZATIONS. THE CLINIC HAS EVIDENCE THAT INTEGRATING STRATEGIES TO BUILD FINANCIAL SECURITY INTO THE WORK OF OTHER SECTORS - FOR EXAMPLE WORKFORCE DEVELOPMENT-IMPROVES OUTCOMES. FOR EXAMPLE, IN A PROJECT WHERE THE CLINIC TRAINED CAREER COACHES TO DO SOME FINANCIAL COACHING, LOW-WAGE WORKERS WHOSE CAREER COACHES ASSISTED THEM IN ESTABLISHING AUTOMATIC SAVINGS DEMONSTRATED A 31 PERCENT HIGHER WEEKLY INCREASE IN INCOME THAN THOSE WHO DID NOT RECEIVE ANY FINANCIAL COACHING SERVICES.
